## **S100. Policy Notes**

Carleton Archery Club, Inc. has a fiscal year of May 1 through April 30. Carleton Archery Club, Inc. divides its fiscal year into three periods for reporting purposes, Summer (May to August), Fall (September to December), and Winter (January to April), which better aligns with the corporation's programming then a quarterly schedule. In accordance with the corporation's articles, all activities are carried out for a non-profit purpose and all funds are used to support the club's archery activities.

For fiscal year 2023-2024, there was no activity in the summer reporting period because the corporation was founded in the fall which is why the first fiscal year starts on 02 September 2023.

Carleton Archery Club, Inc., uses the restricted fund method both to segregate gifts with designated purposes and for funds that the Board has set aside for certain purposes. These funds are governed by section 10 of the club's <u>Financial Management Policy</u> and by either Board resolutions, in the case of funds with a specific Board defined purpose (like the Maintenance Fund), or by the terms set by the donor which the Treasurer is responsible for carrying out (such as the Bank Fee Fund). These funds are held as cash and on deposit.

Gifts were received from members of the corporation this fiscal year. These consisted of cash (\$225) and the remainder in forgone reimbursements for equipment purchases and fee payments made on behalf of the corporation (\$2,630.14). Only members provided gifts, no non-members provided any gifts to the corporation this fiscal year.

## **Definitions and Descriptions**

These are additional descriptions and definitions for the items above:

- Semester, annual and drop-in fees collected to participate in Saturday open shooting sessions in IH2404.
- Fees collected from participants for the use of club bows, arrows, and accessories during Saturday sessions.
- Money collected from participants due to fines levied by a Range Safety Officer according to the arrow fine schedule and under Bylaw 2.
- 4. Fees collected from 18m Thursday shooting in the Norm Fenn Gym.
- 5. Gifts received from members of the corporation (100%) of cash (\$225) and the remainder in forgone reimbursements for equipment purchases and fee payments made on behalf of the corporation (\$2,630.14).
- 6. Amounts collected and paid for the Archery tag event.
- 7. Funds that are transferred to the Carleton University Archery Club pursuant to agreements the corporation has with the CUAC.
- 8. Money spent on archery supplies including bows, arrows, finger tabs and arm guards, bow accessories, and cases.
- Fees paid for Archery Canada and Archery Ontario club membership and insurance. Note, a \$1 fee per member per year is payable to AO for associate membership and will be an expense in future periods and fiscal years.
- 10. Amounts paid for archery coach training.
- 11. Funds that are restricted to the payment of bank fees per a gift restriction.

12. Funds that are collected from equipment use fees as well as fines that are restricted to use for specific range or equipment improvements as directed by the Board.
